The following terms apply for all products leased from 3 Rivers Communications, Inc. By leasing DIRECTV equipment from 3 Rivers Communications, you are agreeing to the following terms and conditions:

1. As the lessee, you assume all responsibilities for the terms listed in this agreement for yourself and on behalf of the DIRECTV programming customer if he/she is different than you.
2. For **New DIRECTV customers**, you must agree to a credit check, provide your Social Security Number, and a valid Credit Card Number.

Activation of DIRECTV Receivers & Programming:

3. All DIRECTV receivers leased from 3 Rivers Communications must be activated at time of installation.
4. For customers upgrading equipment with a self-installation, the equipment will be activated on the account prior to being shipped to the customer. The customer will be responsible for the bill from the date of activation for all self-installed receivers.
5. DIRECTV programming must be activated on each individual DIRECTV receiver leased from 3 Rivers Communications. Activation of a single receiver does not fulfill your obligations under this agreement if you have leased more than one receiver.

Programming Commitment:

6. If you are a **new** DIRECTV customer leasing DIRECTV equipment you agree to activate and keep in good standing the Choice package or higher for 18 months for standard equipment and 24 months for advanced equipment (**Digital Video Recorder, High Definition, or High Definition/ Digital Video Recorder**).
7. If you are an **existing** 3 Rivers Communications/ DIRECTV customer, this programming commitment will supersede any previous 3 Rivers Communications/ DIRECTV programming commitment on your existing account. You are agreeing to keep your service active and in good standing for 18 months for standard equipment or 24 months for advanced equipment (**Digital Video Recorder, High Definition, or High Definition/ Digital Video Recorder**).

Potential Charges:

8. You are pre-authorizing 3 Rivers Communications to charge the credit card you used on this form: **After the DIRECTV equipment has been installed if you cancel and return the DIRECTV equipment you may be liable for a one-time, non-refundable post-installation cancellation fee of up to \$200.00 during the term of your agreement.**
9. You agree to pay 3 Rivers Communications any and all costs associated with the collection of fees should the credit card, which you provide to us, have insufficient funds or be declined for any reason
10. **You are pre-authorizing 3 Rivers Communications to charge your credit card for any balance remaining on your account should you disconnect while you are under contract.**
